

DC BOCCE LEAGUE TUBING TRIP WAIVER AND RELEASE FORM

In consideration of being allowed to participate in the DC Bocce League Tubing Trip (hereinafter "Tubing Trip"), I expressly and willingly agree to assume complete responsibility for any risk of injury that may arise from participation in the Tubing Trip as set forth below:

1. REPRESENTATIONS. I represent that I do not suffer from any heart, lung or other medical condition or disease that might in any way hinder or prevent me from safely participating in the Tubing Trip.
2. ACKNOWLEDGMENT OF RISKS. I acknowledge that I have voluntarily applied to participate in the Tubing Trip which I understand involves outdoor water sports in Harper's Ferry, WV. I am aware the proposed activity of river tubing is a hazardous activity and that I could be seriously injured or even killed.
3. EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY. I am voluntarily participating in this activity with knowledge of the risks of bodily injury, death or property damage and I agree to assume responsibility for all the risks of activities of the Tubing Trip. I agree that if I am injured from said activity, I will not hold the DC Bocce League responsible even if the injuries were caused by negligence on my part or the DC Bocce League, or any other party under or affiliated with the DC Bocce League.
4. RELEASE. On behalf of myself, my heirs, assigns and next of kin, I hereby release DC BOCCE LEAGUE, its principals, directors, officers, agents, employees and volunteers, and their insurers, if any, (Collectively, "Releasees") FROM ANY AND ALL LIABILITY OF ANY NATURE FOR ANY AND ALL INJURY OR DAMAGE (INCLUDING DEATH) TO ME as a result of my participation in the activity, EVEN IF CAUSED BY THE NEGLIGENCE OF ANY OF THE RELEASEES NAMED ABOVE, OR ANY OTHER PERSON (INCLUDING MYSELF).
5. TRANSPORTATION. I also acknowledge that transportation for the Tubing Trip is provided as a courtesy and is not a contractual obligation of the DC Bocce League. I hereby acknowledge that if I fail to report to the bus at the designated time, the bus may leave without me, and I hereby RELEASE THE DC BOCCE LEAGUE FROM ANY OBLIGATION TO PROVIDE TRANSPORTATION SHOULD I FAIL TO OBSERVE THE TRANSPORTATION SCHEDULE.

I HAVE READ AND FULLY AGREE TO THE CONDITIONS SET FORTH IN THIS WAIVER AND RELEASE. I HAVE SIGNED THIS WAIVER FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, PROMISE OR GUARANTEE BEING COMMUNICATED TO ME. MY SIGNATURE IS PROOF OF MY INTENTION TO EXECUTE A COMPLETE AND UNCONDITIONAL WAIVER AND RELEASE OF ALL LIABILITY TO THE FULL EXTENT OF THE LAW. I AM AT LEAST 21 YEARS OF AGE AND MENTALLY COMPETENT TO GRANT THIS WAIVER.
